- A. Apparatus Purchase Update/HGAC: We received notice today that Hughes received the loan payment for the two attack tenders. We discussed this previously, but we used the Houston-Galveston Area Council procurement contract for this purchase. The monthly payments will be around \$25,000 a month for four years with a 4.53% interest rate which equates to around \$111,000 in interest total. We saved about \$98,000 by ordering now and paying up front. The first payment will be due in November.
- **B. Employee Evaluations:** Evaluations for Lt Brent Cross, FF Nathan Hemenway, and FF Brian Harris were conducted. It is recommended they receive their next step increase based on their above average evaluations.
